EGMP ORGANISATIONAL STRUCTURE

European The Goose Management International Working Group (EGM IWG) serves as the main coordinating and decision-making body of the EGMP and is composed of national delegations comprising representatives of national governments, their designated national experts and other national stakeholders. The European Commission is also a member of the EGM IWG. Several relevant international organisations have received permanent observer status to the EGM IWG and individual experts are invited to meetings, as necessary.

The *Chairmanship* has been assumed by the UK (represented by Prof Des Thompson) since June 2020 and its term of office expired at the close of EGM IWG7, in 2022. However, the EGM IWG agreed to exceptionally extend UK's term for another year, until June 2023 at the close of EGM IWG8.

There are *six Task Forces* operating under the EGMP:

- Pink-footed Goose Task Force
- Taiga Bean Goose Task Force
- Agriculture Task Force
- Barnacle Goose Task Force for Russia/ Germany & Netherlands Population
- Barnacle Goose Task Force for E. Greenland/Scotland & Ireland and Svalbard/SW Scotland Populations
- Greylag Goose Task Force for NW/SW European Population

The Task Forces are aimed to support the EGM IWG in coordination and facilitation of the respective ISSAP and ISSMP implementation.

The *EGMP Data Centre* is responsible for providing the necessary scientific analysis, assessments and subsequent proposals for conservation and management options for EGMP related issues. The UNEP/AEWA Secretariat and Aarhus University in Denmark have signed a Memorandum of Cooperation under which Aarhus University hosts the Data Centre for the EGMP.

Under the coordination of the EGMP Data Centre, the *International Modelling Consortium*, consisting of an international partnership of scientific institutions, collaborates on the development of population models (to support the optimisation of harvest offtake and analyse the cumulative impact of derogation killing and harvest) and so-called impact models to understand the relationship between goose abundances and socioeconomic as well as ecosystem impacts caused by geese.






Figure 2. AEWA EGMP Secretariat Staff Composition

AEWA EGMP Secretariat

AEWA Head of Science, Implementation and Compliance Unit

Mr Sergey Dereliev

Part of Mr Dereliev's staff time, covered by the AEWA core budget, is allocated to oversee the EGMP process and to supervise the day-today work of the EGMP team.

EGMP Coordinator

Ms Eva Meyers

Ms Meyers serves as the Coordinator of the EGMP, as full-time P-2 Associate Programme Management Officer since July 2017. This post is fully funded through the voluntary contributions provided by the EGMP Range States. The EGMP Coordinator has an annual workplan which is revised mid-term and approved by the Head of Science, Implementation and Compliance Unit, as well as an annual evaluation of performance.

Programme Management Assistant

Ms Shenay Huseynova serves as the Programme Management Assistant (PMA) since June 2022. The EGMP PMA has an annual workplan which is revised mid-term and approved by the EGMP Coordinator, as well as an annual evaluation of performance.

EGMP Data Centre

Professor Madsen from the Department of Ecoscience at Aarhus University, Denmark, acts as the head of the EGMP Data Centre (30% person-year). This part-time post is funded through the voluntary contributions provided by the EGMP Range States.

Goose Monitoring Coordinator

Dr Gitte Høj Jensen serves as the Goose Monitoring Coordinator based in Aarhus University. This fulltime post is fully funded through the contributions provided by the EGMP Range States for the platform's core budget.

Population Modelling Experts

Dr Fred A. Johnson

Dr Fred A. Johnson is a part-time Senior Researcher at the Department of Ecoscience at Aarhus University, Denmark. He is the developer of the adaptive management frameworks and the assessor for Pink-footed Goose, Taiga Bean Goose, Greylag Goose, and Greenland Barnacle Goose. The EGMP core budget funds a 40% person-year position, which is supplemented by project funding from various Range States or funds. 


Figure 3. EGMP Data Centre Staff Composition

PARTICIPATING RANGE STATES OF THE EGMP/FUNDING




Figure 4. Map of the EGMP participating and non-participating Range States

Participating Range States of the EGMP

The EGMP has 16 participating Range States (see Figure 2), 15 national governments and the European Commission: Belarus, Belgium, Denmark, Estonia, EU, Finland, France, Germany, Iceland, Ireland, Latvia, Netherlands, Norway, Sweden, Ukraine and United Kingdom.

Ireland was the latest country joining the EGM IWG, in June 2021. Spain is contributing in the Greylag Goose implementation process through data provision. Poland has designated a national expert to participate in the Taiga Bean Goose Task Force. Spain, Lithuania, Poland and Russia officially remain non-participating Range States of the EGMP.

Funding

The AEWA Secretariat would like to express its appreciation for the financial support received towards the implementation of the EGMP processes. A detailed financial report outlining budget, funding and expenses is provided as document <u>AEWA/EGMIWG/8.16</u>.

ISSMP for the Pink-footed Goose (PfG)

In spring 2023, the Data Centre produced the annual monitoring and harvest assessment chapter for the PFG (due June 2023).

ISSAP for the Taiga Bean Goose (TBG)

In spring 2023, the Data Centre produced an annual monitoring and harvest assessment report for the TBG, with focus on the Central Management Unit.

ISSMP for the Greylag Goose (GG)

Progress has been made towards moving to a dynamic and model-based management with the development of a preliminary population model and a utility function (I.e., how

In spring 2023, Sovon and Wageningen Environmental Research updated the population estimates for the Russian/ Germany and Netherlands population of Barnacle Goose. In spring 2023 the Data Centre, produced the second assessment of the cumulative effect of offtake for the East Greenland/Scotland and Ireland population of Barnacle Goose.

Impact models

The Data Centre, together with the EGMP Modelling Consortium and the EGMP Agricultural Task Force, has coordinated reviewed the evidence for relationships between increasing goose abundances and impacts on agricultural conflict/damage,

stakeholder satisfaction varies as populations deviate from their target) in order to evaluate levels of offtake. Moreover, progress has been made on summer counts to estimate the population size at MU level. Particularly on MU1, where an estimate was made for the first time, based on data from summer 2022. In spring 2023, the Data Centre produced an annual monitoring and assessment report for the GG.

ISSMP for the Barnacle Goose (BG)

In autumn 2022, the Data Centre together with NINA reviewed the IPM for the Russian/

with particular focus on Barnacle Geese and Greylag Geese; however including evidence from other EGMP goose populations as well. The synthesis will be presented at EGM IWG in June 2023.

EGMP Database and GitLab

Update of the EGMP Database was made with new data, figures and description of methods. Furthermore, EGMP GitLab is updated with new projects, each of which is now assigned a DOI for easier reference.



EGMP Ad-hoc Communication Working Group

In spring 2022, the EGMP Secretariat and Data Centre sent out a questionnaire to the EGM IWG asking a number of important questions regarding the functioning of the EGMP and suggested improvements. Based on the collected feedback, it became clear that EGMP communication efforts needed improvement. As a result, at EGM IWG7 an adhoc communications group was established. The group has focused on developing a communication plan, restructuring the website and producing EGMP briefing notes and fact sheets.

The group is working on the following activities:

- Draft Fact sheets (available in the Task Force MS Teams/Share point folder <u>Communications Working Group;</u>)
- Briefing note of the Population status and <u>Management decisions</u> (to be produced shortly after EGM IWG meetings, based on each annual Population Status and Offtake Assessment Report);
- Improvement of the EGMP website (updating its structure and content);
- Production and distribution of EGMP newsletters 2-3 times a year;

• Development of a workflow for getting the EGMP success stories published.

The membership of the group is open for those interested to participate and contribute.

EGMP Website

The Secretariat together with the joint CMS/AEWA Information Management, Communication and Awareness Unit (IMCA) has worked on the further development of the EGMP website (https://egmp.aewa.info/) producing a new template and adding content and updating information accordingly. The website has been upgraded from Drupal 7 web content management system to Drupal 9. Along with the upgrade, the overall design of the website and its structure have been improved as well. While the website upgrade has been completed, the migration of the content to the new website is still underway.
