


Figure 1. Role of the respondents in the EGM IWG




Figure 2. Preferences for meeting format and day length




Figure 3. Preferences for meeting format and day length in an online meeting




Figure 4. Preferences on the length of agenda items, presentations and sessions in online and face-to-face meetings





Figure 5. Preferences on the length of presentations and document introductions during EGM IWG meetings





Figure 7. Opinions on the time given to discussions and interventions during online meetings




Figure 9. Opinions on the clarity of decisions taken during the EGM IWG meetings





Figure 10. Preferences for participation in the early stage of document drafting




Figure 12. Opinions on the clarity of the processes under the EGMP




Figure 13. Opinions on the concepts developed under EGMP




Figure 14. Opinions on the results and outputs of the EGMP processes




Figure 15. Opinions on the communication of the results of the EGMP





Figure 16. Opinions on the accessibility of the relevant information




Figure 19. Opinions on the functioning of the EGMP Task Forces
